# Accessible Transit - Service Agreement - Amey's Greenwood Taxi Ltd.

The Mayor and CAO were authorized to enter into a service agreement with Amey's Greenwood Taxi Ltd. for the purpose of providing accessible public transit services for eligible residents of the Amherstview transit area for a one year period as a "pilot project," commencing on July 1, 2021, with the option to renew, for an additional one year period, subject to annual budget approval. Staff were directed to provide a project status update to Council at the end of 2021, or sooner if the costs exceed \$75,000 in 2021.

# **Loyalist East Business Park Pricing**

Staff were directed to set the price per acre for the remaining Loyalist East Business Park lots under phases 1 and 2 at \$105,000 per acre, with the intent of recovering costs for phase 2 of development. Council confirmed that any unrecovered servicing costs will not be recovered under the Development Charges Act, 1997. Staff were also directed to review pricing alternatives and options and provide a report with recommendations for Council's consideration.

# **Financial Relief Measures**

To encourage residents to remain safe while under a provincewide Stay-at-Home order, Council approved the following financial relief measures for residents:

- Late fees, interest or penalties on Utility and Property Tax that would normally be accrued until 4 weeks after the current Stay-at-Home order is lifted.
- The extension of the early bird rate of \$15.00 for dog tags throughout the 2021 calendar year.

# **Economic Development Opportunities Report - L&A County**

Stephen Paul, Director, Community & Development Services with the County of Lennox & Addington provided an update and presentation to Council on a recent Economic Development opportunities study conducted by the County.

### **Ontario Municipal Partnership Fund**

Council authorized the Mayor to write a letter to Premier Ford requesting that the Loyalist Township Ontario Municipal Partnership Fund allocation be reviewed, and specifically request Provincial support for moving Loyalist Township from the City of Kingston census area to the County of Lennox & Addington census area.
