Public Meetings

By-Law 2022-009 -A public meeting was held to receive comments regarding By-law 2022-009 Amend By-law 2011-006 being a by-law to control noise.

Community Safety and Wellbeing Plan

Council approved, in coordination with the three other local tier municipalities in Lennox & Addington County, a contracted approach through a formal Request for Proposal (led by the Town of Greater Napanee), for the completion of the Loyalist Community Safety and Well Being Plan (CSWB).

Banking Agreement Extension

The current banking agreement with the Royal Bank of Canada (RBC) and the new agreement to be entered into with the Royal Bank of Canada for the provision of banking services for another 5 years, commencing May 31, 2022, was approved.

Adoption of 2022 Capital Budgets

Council adopted the 2022 Capital Budget which states that the 2022 general rate capital budget be received totalling \$10,663,200. The 2022 utilities capital budget be received totalling \$3,942,600.

Recreation & Facilities Staffing - Parks and Natural Assets

Council adopted the recommendation that a full-time permanent Assistant Supervisor of Parks and Natural Assets position be added to the Township effective May 1, 2022, to be funded from the Working Fund, with no impact on the 2022 tax rate.

Recreation Programs Partnership Agreement - BGC South East

Council received a report and authorized the Mayor and CAO to execute an agreement with Boys & Girls Club (BGC) South East to provide "child care" recreation programs.

Proposal to Launch Hybrid Meeting Model and Return to In Person Meetings

Council received a report proposing the launch of a hybrid meeting model and return to in-person meetings with a phased in approach.

- Phase 1 target date be set for the April 25th Council meeting.
- Phase 2 target date set for the first meeting in June.
- The hybrid model will be monitored for four months and reported on to Council in September.

Loyalist Estates Phase 8 - Assumption of One Foot Reserve

Council adopted by-law 2022-023 being a by-law to assume a one-foot reserve located on the west end of Oakmont Drive.

Objection to the Addition of 4669 Bath Road to the Loyalist Township Municipal Register of Properties of Cultural Heritage Value or Interest

Council authorized the removal of the property located at 4669 Bath Road (Hwy 33) from the Municipal Register as a listed property.

Results of NRP 2021-31 Layer Cake Hall Restoration

Council approved by-law 2022-024, being a by-law to authorize the Mayor and CAO to enter into an agreement with Ecclesiastical Refinishing Inc. for the Layer Cake Hall Restoration Project.

County Development Approval Process - Request for Support

Council adopted the recommendation of the Municipal Working Group that ESRI Canada/City Works being the preferred proponent for the Development Approvals Project.

Canada Community Revitalization Fund Funding Agreement

Council provided approval to enter into a funding agreement with Federal Economic Development Agency for Southern Ontario.
