Affordable Housing Partnership Program

Council received a report from the Planning Division that identified three potential properties within Loyalist that may be suitable for the development of a housing complex within the County of Lennox & Addington through the Affordable Housing Partnership Program. Council approved submitting Property A (Odessa) to the County Social Services Department as a candidate for the Affordable Housing Partnership Program, and, that if Council of Lennox and Addington County selects this property, Council supports the transfer of ownership of that property to the County for \$1.00.

Public Meeting - Official Plan Comprehensive Review Amendment - Public Meeting and **Recommended Council Adoption**

A Public Meeting was held to consider a proposed comprehensive amendment update to the Loyalist Township Official Plan, in accordance with Section 17(15) of the Planning Act. Council endorsed the proposed final Official Plan Comprehensive Amendment and enacted and passed By-law 2021-062 to amend the Official Plan for the Township of Loyalist Planning Area.

Public Meeting - 2021 Draft Development Charges By-law

A Public Meeting was held to receive public comment on the 2021 Draft Development Charges By-law. Prior to opening the floor to public comment, the external consultant, Hemson Consulting Ltd. provided council with a presentation on the Development Charges Study and outlined some proposed changes to the draft By-law.

COVID-19 Vaccination Protocol

Council received a report from the Business Services department which provided information on the Township's approach regarding COVID -19 vaccinations and Council approved the Loyalist Township COVID-19 vaccination protocol.

Facility Allocation Policy

Council received a report from the Community and Customer Services Department which proposed updates to policies relating to the allocation of Township facilities including indoor facilities, parks and sports fields for customer use. The allocation policy identifies order of priority for allocation of use of Township facilities. Council approved the Facility Allocation Policy as presented and enacted and passed By-law 2021-060.

Recreation Cancellation and Refund Policy

Council received a report from the Community and Customer Services Department which proposed establishing a formalized Recreation Cancellation and Refund Policy. Council approved the Recreation Cancellation and Refund Policy as presented and enacted and passed By-law 2021-061.

Transition of the Blue Box Program to Full Producer Responsibility

Council received a report from the Community and Customer Services Department which advised Council that the final Blue Box regulation (Ontario Regulation 391/21) under the Resource Recovery and Circular Economy Act, 2016 passed on June 3, 2021 and this action by the provincial government will transition the municipal Blue Box program to full producer responsibility. Additionally, this report informed Council of decisions that need to be made in the lead up to Loyalist Township's scheduled transition date of July 1, 2025.

Council Supported the Following Resolutions Circulated from other Municipalities

Anishinabek Nation - Memo to inform organizations and businesses that the Province of Ontario has assured Anishinabek Nation that First Nation Status Cards will be accepted widely and without interference or refusal, provided the name on the card corresponds with the name on the proof of vaccination.
