### Improving Public Transportation - Progress Report #2

Council approved a joint venture with the Town of Greater Napanee to provide a coordinated transportation service for a proposed route connecting the Town of Greater Napanee, Loyalist Township and the County of Lennox & Addington. Staff were authorized to submit a proposal to Lennox and Addington County following receipt of a Council resolution from the Town of Greater Napanee approving the joint venture.

### Public Meeting - Draft Backyard Hens Licensing By-law

A Public Meeting was held to receive comments on the draft Backyard Hens Licensing By-law. Council referred the By-law to a future Committee of the Whole meeting for further discussion of the draft By-law along with the corresponding public comments that were received.

### 2021 Draft Development Charges By-law - Request for Intention to Adopt

Following a public consultation process, Council provided intention to adopt the draft development charge study and draft development charge by-law (2021-066) at the October 25, 2021, Regular Council meeting, as originally targeted.

### Progress of Negotiations - Use of Amherst Island Public School Facilities

Council requested that staff bring a report to Council on the progress of negotiations for an agreement between Loyalist Township and the Limestone School Board in respect to the use of the Amherst Island Public School facilities.

### Request for Leave - Councillor Porter

Council has referred the request to the next Closed Session meeting of Council (October 25, 2021) to discuss the portion of the request that was redacted as it related to personal matters about an identifiable individual.
